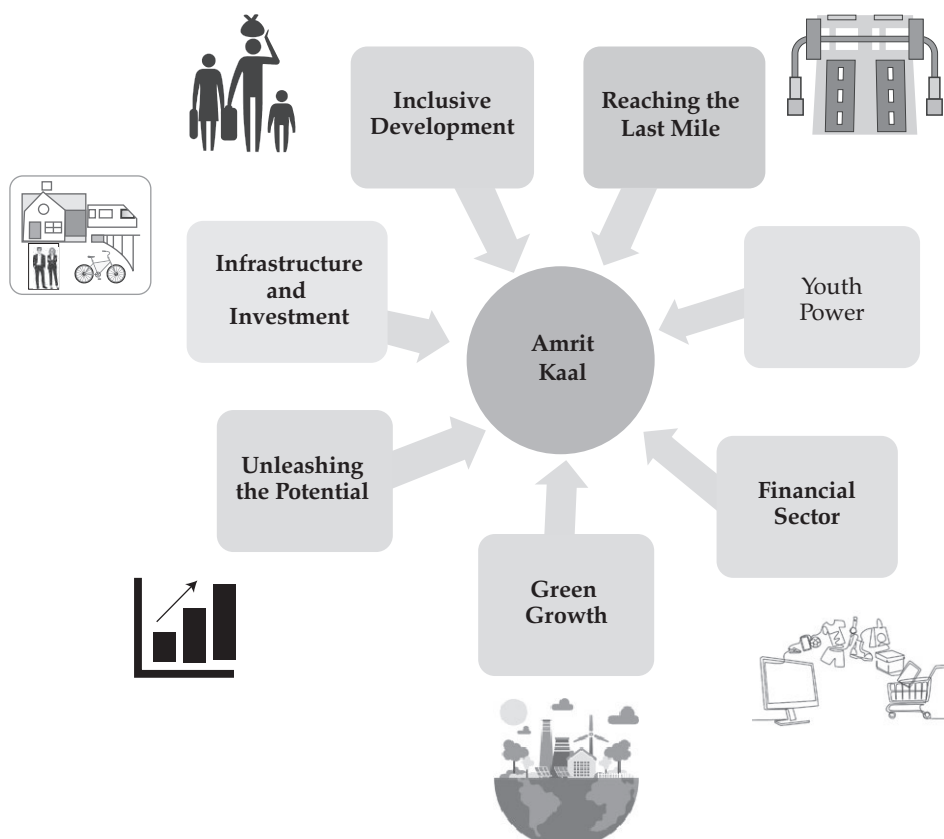

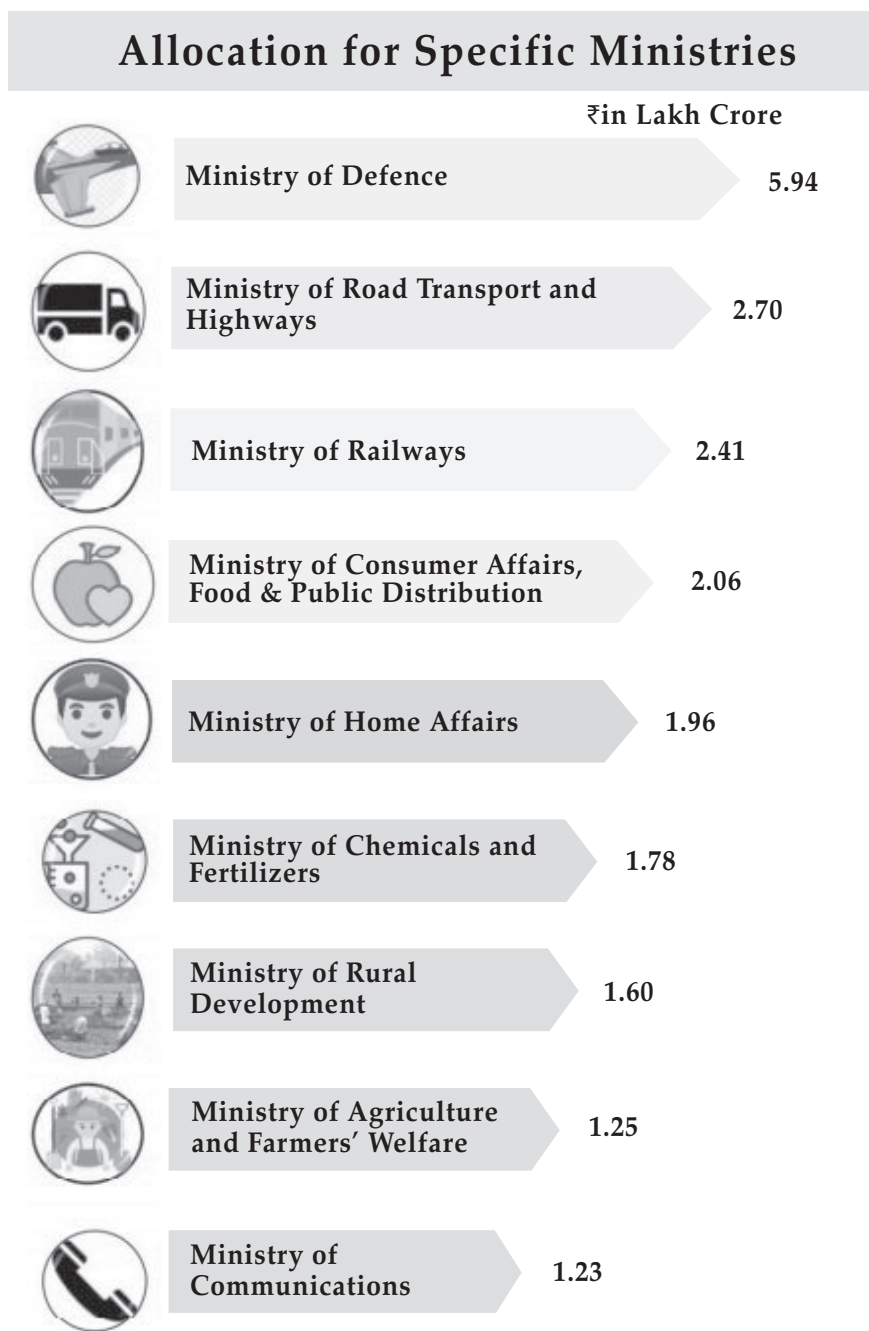
Union Budget 2023-24

 7. Financial Sector



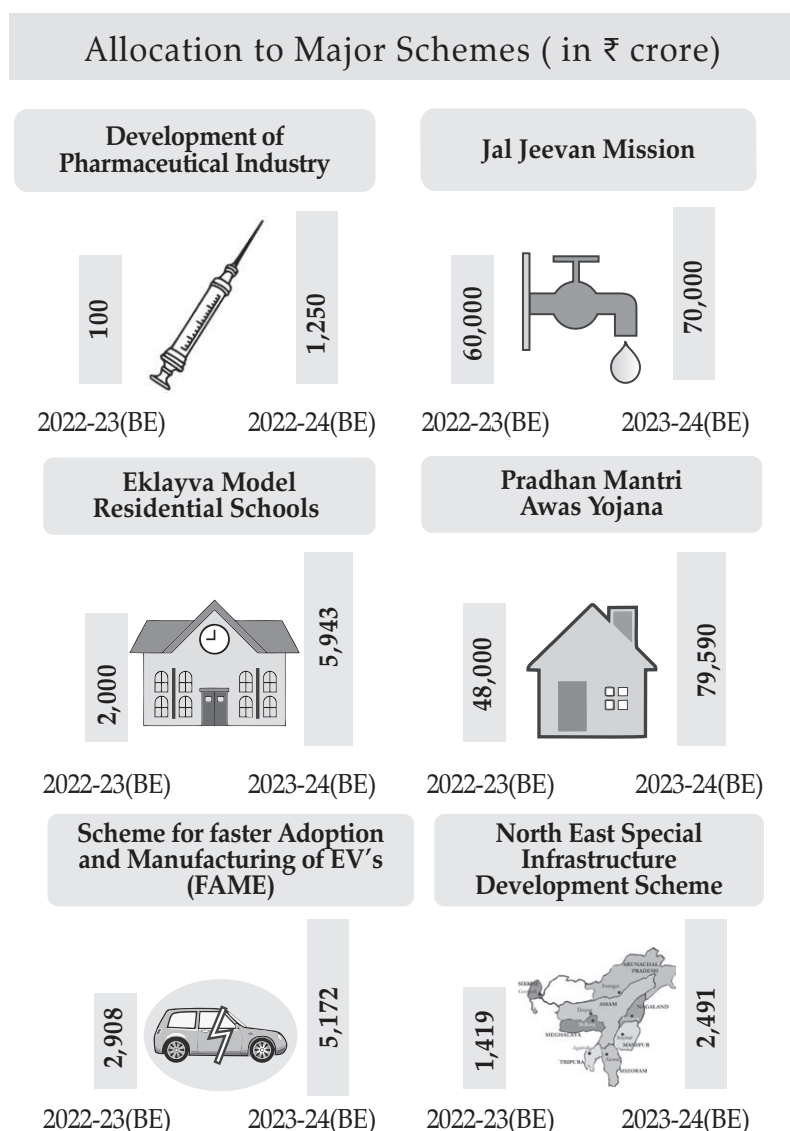

- ◆ 100 labs to be set up for 5G services-based application development to realize new opportunities, business models and employment potential, the 5G labs will cover applications such as smart classrooms, precision farming, intelligent transport system and healthcare applications.
- ◆ Mahila Savings Certificate for two years up to March 2025, a new small savings scheme announced for women.
- ◆ NITI Ayog policy expanded to continue for another three years.
- ◆ Finance Minister said ₹2 lakh crore for the entire year will be borne by the central government under the 'PM Garib Kalyan Anna Yojana' scheme.
- ◆ Allocation of ₹35,000 crore for energy transition and net-zero carbon emission target will be made.
- ◆ The maximum deposit for the senior citizen saving scheme is to be enhanced to ₹30 lakh from ₹15 lakh.
- ◆ The maximum deposit limit for the Monthly Income Account Scheme is to be enhanced from ₹4.5 lakh to ₹9 lakh for a single account and from ₹9 lakh to ₹15 lakh for joint account.
- ◆ Per capita income has more than doubled to ₹1.97 lakh in around nine years.
- ◆ Indian economy has increased in size from being 10th to 5th largest in the world in the past nine years.
- ◆ Credit guarantee for MSMEs of ₹9,000 crores infused in the corpus, allowing additional collateral-free credit of ₹2 lakh crores, starting from April 1, 2023.
- ◆ EPFO membership has more than doubled to 27 crores.
- ◆ Atmanirbhar Clean Plant Program with an outlay of ₹2200 crore to be launched to boost availability of disease-free, quality planting material for high value horticultural crops.
- ◆ 500 new 'waste to wealth' plants under the GOBARdhan (Galvanizing Organic Bio-Agro Resources Dhan) scheme to be established to promote a circular economy at a total investment of ₹10,000 crore. 5 percent compressed biogas (CBG) mandate for all organizations marketing natural and biogas.

- ◆ 30 Skill India International Centres to be set up across different States to skill the youth for international opportunities.

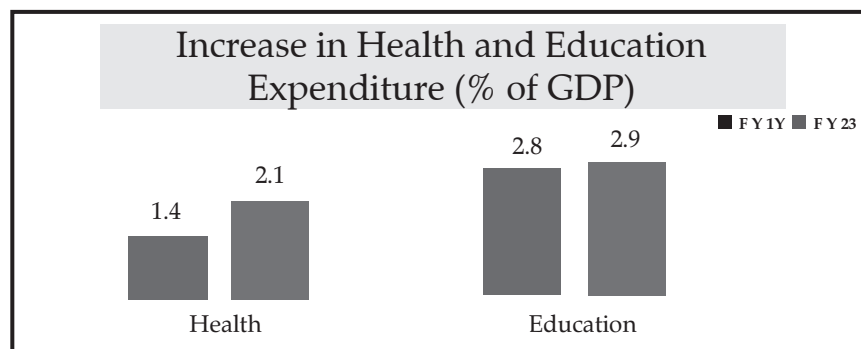
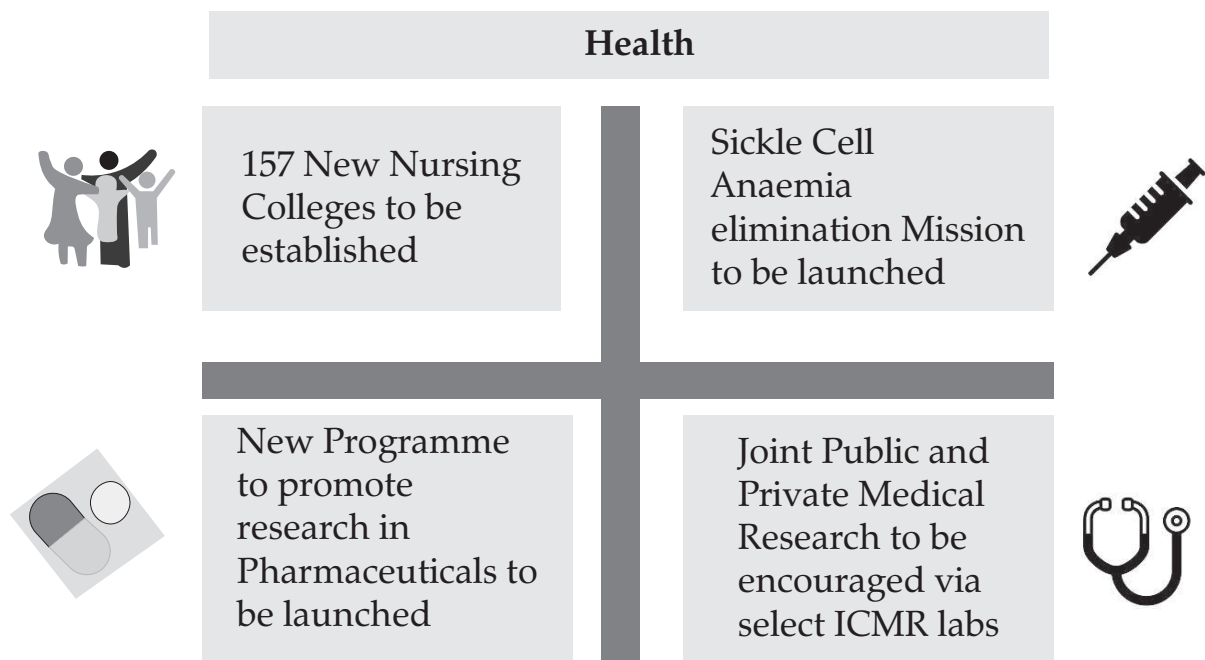

- ◆ Phase 3 of the E-Courts project is to be launched with an outlay of ₹7,000 crores for efficient administration of justice.
- ◆ Annual production of 5 MMT under the Green Hydrogen Mission to be targeted by 2030 to facilitate the transition of the economy to low carbon intensity and to reduce dependence on fossil fuel imports.
- ◆ Sickle Cell Anaemia elimination mission to be launched.



- ◆ 157 new nursing colleges to be established in co-location with the existing 157 medical colleges established since 2014.
- ◆ ₹5,300 crores to be given as central assistance to the Upper Bhadra Irrigation Project to provide sustainable micro irrigation and filling up of surface tanks for drinking water.
- ◆ “PM Programme for Restoration, Awareness, Nourishment and Amelioration of Mother Earth” (PM-PRANAM) will be launched to incentivise States and Union Territories to promote alternative fertilizers and balanced use of chemical fertilizers.
- ◆ Pradhan Mantri Kaushal Vikas Yojana 4.0, will be launched to skill lakhs of youth within the next three years covering new age courses for Industry 4.0 like coding, AI, robotics, mechatronics, IOT, 3D printing, drones, and soft skills.
- ◆ ‘Mangrove Initiative for Shoreline Habitats & Tangible Incomes’ (MISHTI), will be taken up for mangrove plantation along the coastline and on salt pan lands through convergence between MGNREGS, CAMPA Fund and other sources.
- ◆ Amrit Dharohar scheme will be implemented over the next three years to encourage optimal use of wetlands, enhance bio-diversity, carbon stock, eco-tourism opportunities and income generation for local communities.

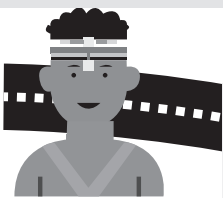

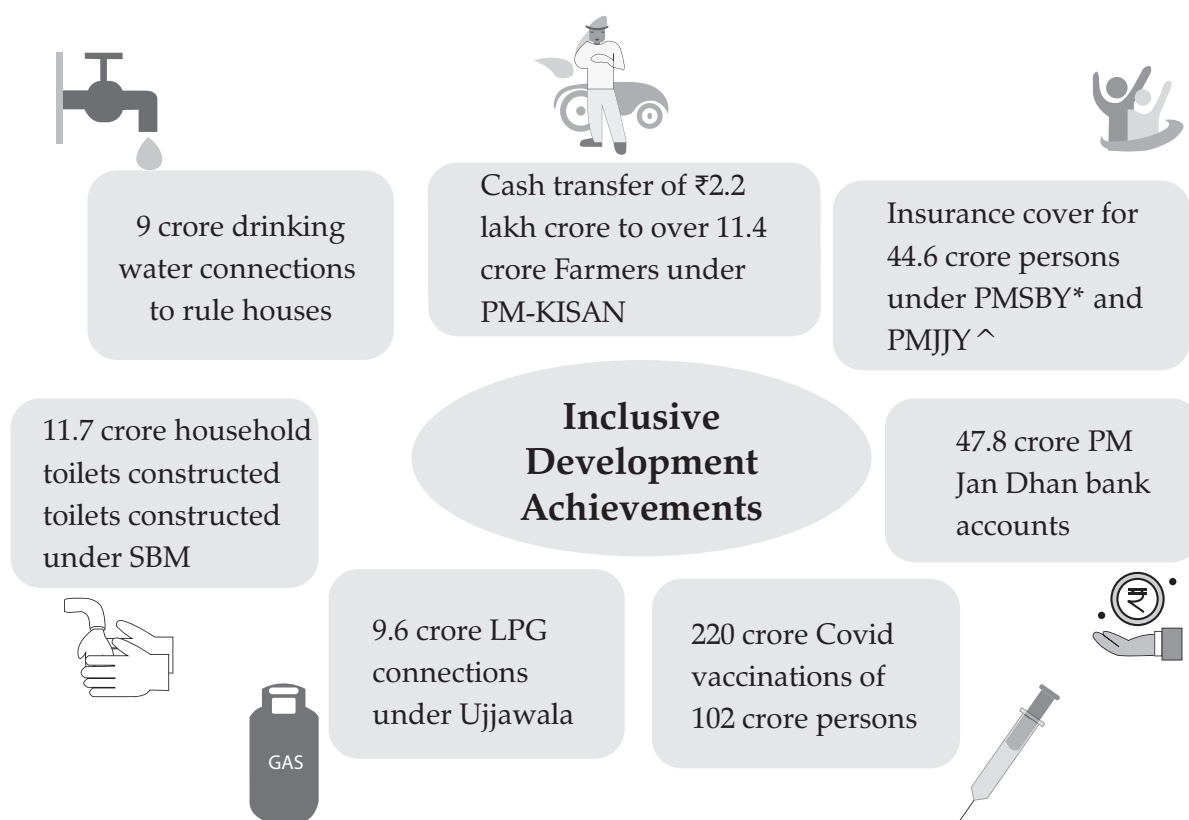

- ◆ ₹15,000 crore for implementing Pradhan of Pradhan Mantri PVTG Development Mission over the next three years under the Development Action Plan for the Scheduled Tribes.
- ◆ To commemorate Azadi Ka Amrit Mahotsav, a one-time new small savings scheme, Mahila Samman Savings Certificate to be launched. It will offer a deposit facility of upto ₹2 lakh in the name of women or girls for a tenure of 2 years (up to March 2025) at a fixed interest rate of 7.5 per cent with a partial withdrawal option.



- ◆ 11.7 crore household toilets constructed under Swachh Bharat Mission.
- ◆ 9.6 crore LPG connections provided under Ujjwala.
- ◆ 47.8 crore Pradhan Mantri Jan Dhan bank accounts.
- ◆ Insurance cover for 44.6 crore persons under Pradhan Mantri Suraksha Bima and Pradhan Mantri Jeevan Jyoti Yojana.
- ◆ Cash transfer of ₹2.2 lakh crore to over 11.4 crore farmers under Pradhan Mantri KisanSamman Nidhi.

Direct Taxes

- ◆ Direct Tax proposals aim to maintain the continuity and stability of taxation, further simplify and rationalise various provisions to reduce the compliance burden, promote the entrepreneurial spirit and provide tax relief to citizens.
- ◆ Rebate limit of Personal Income Tax to be increased to ₹7 lakhs from the current ₹5 lakhs in the new tax regime. Thus, persons in the new tax regime, with income up to ₹7 lakh will not have to pay any tax.
- ◆ Tax structure in the new personal income tax regime, introduced in 2020 with six income slabs, to change by reducing the number of slabs to five and increasing the tax exemption limit to ₹3 lakhs. Change to provide significant relief to all taxpayers in the new regime.
- ◆ Under the new personal tax regime, six income slabs have been implemented. The government has also increased the tax exemption limits in some of these categories.

- ◆ The new income tax regime to be made the default tax regime. However, citizens will continue to have the option to avail the benefit of the old tax regime.
- ◆ Proposal to limit income tax exemption from proceeds of insurance policies with very high value. Where the aggregate premium for life insurance policies (other than ULIP) issued on or after 1st April, 2023, is above ₹5 lakhs, income from only those policies with aggregate premiums up to ₹5 lakhs shall be exempt.
- ◆ Minimum threshold of Rs. 10,000/- for TDS to be removed and taxability relating to online gaming to be clarified. Proposal to provide for TDS and taxability on net winnings at the time of withdrawal or at the end of the financial year.

Indirect Taxes

- ◆ Number of basic customs duty (CBD) rates on goods, other than textiles and agriculture, reduced to 13 from 21.
- ◆ Excise duty is exempted on GST-paid compressed biogas contained in blended compressed natural gas.

- ◆ Extend the customs duty exemption to import of capital goods and machinery required for manufacture of lithium-ion cells for batteries used in electric vehicles.
- ◆ Basic customs duty reduced on parts of open cells of TV panels to 2.5 per cent.
- ◆ Basic customs duty on heat coil manufacturing of electric kitchen chimneys reduced to 15 per cent from 20 per cent.
- ◆ Basic customs duty on crude glycerin for use in the manufacture of epichlorohydrin reduced to 2.5 per cent from 7.5 per cent.
- ◆ Budget proposed to nullify the BCD on seeds used in the manufacturing of Lab Grown Diamonds from the current 5%.
- ◆ Duties on articles made from dore and bars of gold and platinum increased.
- ◆ Import duty on silver dore, bars and articles increased.
- ◆ Basic customs duty rate on compounded rubber increased to 25 per cent from 10 per cent or 30 per kg, whichever is lower.
- ◆ National Calamity Contingent Duty (NCCD) on specified cigarettes revised upwards by about 16 per cent.
- ◆ Legislative Changes in Customs Laws.
- ◆ Customs Act, 1962, to be amended to specify a time limit of nine months from date of filing application for passing final order by Settlement Commission.
- ◆ Customs Tariff Act to be amended to clarify the intent and scope of provisions relating to Anti-Dumping Duty (ADD), Countervailing Duty (CVD), and Safeguard Measures.

- ◆ To raise the minimum threshold of tax amount for launching prosecution under GST from one crore to two crore.
- ◆ To reduce the compounding amount from the present range of 50 to 150 per cent of tax amount to the range of 25 to 100 per cent;
- ◆ To restrict filing of returns/statements to a maximum period of three years from the due date of filing of the relevant return/statement; and
- ◆ To enable unregistered suppliers and composition taxpayers to make intra-state supply of goods through E-Commerce Operators (ECOs).

Fiscal deficit:

- ◆ The fiscal deficit is estimated to be 5.9% of the GDP in FY 2023-24.
- ◆ Net borrowings to finance the fiscal deficit are estimated to be ₹11.8 lakh crore.

Capital investment:

- ◆ The capital investment outlay increased for the third year in a row by 33% to ₹10 lakh crore, which would be 3.3% of GDP and almost three times the outlay in 2019-20.

Agriculture:

- ◆ Credit target for agriculture and allied sector has been announced to be increased to 20 lakh crore with focus on animal husbandry, dairy and fisheries.
- ◆ **PM Vishwakarma Kaushal Samman (PM VIKAS):** The first-of-its-kind package assistance endeavors to improve the quality of, scale and reach of the products made by traditional artisans and craftspeople. Components of the scheme would not only provide financial support

but also access to advanced skill training, knowledge of modern digital techniques and efficient green technologies, digital payments and social security.

- ◆ **Vivad se Vishwas I:** If MSMEs failed to execute contracts during the pandemic period, 95% of the forfeited amount relating to bid or performance security would be returned to them by the government or its undertakings.

Credit Guarantee:

- ◆ The scheme for MSMEs has been revamped with an infusion of ₹9,000 crore in the corpus. It will be enforced from April 1, 2023. This would enable an additional collateral-free guaranteed credit of ₹2 lakh crore.
- ◆ The cost of credit would be reduced by about 1 percent.

Green energy:

- ◆ The budget provided ₹35,000 crore for priority capital investments towards achieving energy transition and to achieve the goal of net zero emissions by 2070.
